COVID-19 Protocol to Return to Racing

Jockeys with more than fifty-percent (50%) of their mounts having taken place at Charles Town between January 1, 2020 and March 21, 2020 will be considered Charles Town based riders and permitted in the jockeys room. Any jockey who travels from state to state or rides in another jurisdiction will be subject to a 14-day mandatory quarantine.

Below is the list of riders that will be permitted to participate in live racing. Inclusion on this list does not mean the jockey is willing to ride. Any riders not listed must have approval from the Stewards and Racing Secretary to be named on a horse and to enter the jockey's room.

****Riders must call and check on every day or they will be removed from horses they are named on.**
